Office Order

The FSS Act, 2006 has become operational w.e.f. 5<sup>th</sup> Aug, 2011. The earlier enactments and orders viz. FPO/MFPO/MMPO/PFA etc. have been repealed. There will be no work under the earlier enactments/ orders and henceforth enforcement of food laws would be under the provisions of Rules/Regulations notified under FSS Act, 2006. Therefore it has become necessary to re-allocate work to existing officers /staff and re-organise the Regional Offices for smooth functioning of work related to Central Licensing and Imported Food Process Clearance as per the provisions of new law.

2. The division of staff at Regional Offices to look after work of Central Licensing and Imported Food process Clearance shall be as under with immediate effect:-
